

# LCMS REGULATIONS - STUDENT COMPETITION & CONCERT - 2025

**APPLICATIONS:**     **DEADLINE DATE : WEDNESDAY, MARCH 5TH 2025**  
Send Application Form duly completed with the correct fee paid either  
1) by e-transfer to [info@lakeshorechambermusic.org](mailto:info@lakeshorechambermusic.org) with student name  
or 2) by cheque sent to the Lakeshore Chamber Music Society, P.O. Box 10008 CSP  
Sainte-Anne, Sainte-Anne-de-Bellevue QC H8X 0A6. Applications received after March  
5th will **not** be considered. **Application fees are not refundable.**

**FEES**                     **Soloists:** Junior: \$20; Senior: \$25; \$15 per additional participants (Junior or Senior)  
from the same family.

**Ensembles:** Junior: \$20; Senior: \$25; to a maximum of \$75 per ensemble.

**ELIGIBILITY**             Candidates **MUST** be residents of the territory served by the Society (Lachine, Dorval,  
Dollard-des-Ormeaux, Roxboro and Pierrefonds and the western boundaries of Hudson,  
St. Lazare, Vaudreuil-Dorion and Rigaud) while in the case of ensembles, at least 60%  
of the members of the ensemble must be residents of the above territory.  
Candidates may enter in one of the following categories:  
**Junior:** Ages 4 to 11 by April 1<sup>st</sup>, 2025; **Senior:** Ages 12 to 18 by April 1<sup>st</sup>, 2025

**INSTRUMENTS**         Strings, winds, brass, piano, organ, harpsichord and guitar are admissible but **not voice.**

**REPERTOIRE**             Junior category: Any piece(s) that can be performed in 2 to 5 minutes.  
Senior category: Any piece(s) that can be performed in 4 to 10 minutes.  
**PERFORMANCES EXCEEDING THE TIME LIMIT WILL NOT BE ACCEPTED.**

**IMPORTANT:** Please indicate the duration of the piece(s) on the Application Form.

Please note adjudicators will select which piece(s) are to be performed at the Concert.

Note that unless the music played is written for solo instrument, students (other than pianists) must be accompanied.

There can be no change in the music selection after the audition deadline of March 5th 2025. The auditioned piece(s) selected is/are to be played in the Concert.

*Each candidate is asked to bring two(2) copies of their music WITH THE FIRST BAR OF EACH LINE NUMBERED to the auditions for the use of the adjudicators -- they will not be returned unless requested.*

Video and/or audio recording of a candidate's performance are allowed and encouraged, but must have prior permission from the candidate. Note: Auditions are private except for family and friends of the participant.

**LOCATION**                     Merging Waters United Church, 24 Maple Avenue, Sainte-Anne-de-Bellevue. Please enter by the Adair Hall entrance (on the left) and follow the signs.

**DATE AND TIME**         **Auditions will be held on Saturday March 22<sup>nd</sup>, 2025.** Candidates will be notified of their audition time by email. Candidates must arrive at the auditions at least 15 minutes before they are scheduled to play. **The assigned audition time cannot be changed.**

**NOTIFICATION**         Candidates will be notified by mail/email during the week following the Auditions as to whether they have been selected to play in the Student Concert on Sunday, April 6<sup>th</sup>, 2025. If chosen, they are expected to play at the Concert.
